Public Comments

1. Bill Mulhern- Richwood Subdivision Homeowners Association President

Mr. Mulhern thanks the commission for getting Ordinance 14-08 drafted and placed on the agenda so quickly. Mr. Mulhern referenced the city's Comprehensive Plan which stated that the city would work with Homeowner's Associations and questioned why he hadn't been contacted yet. However, he did encourage the city to work more with local neighborhood associations to assist more with enforcement issues.

Garrett Fowles responded that if a neighborhood doesn't have an association established during development, it's very hard to get everyone to buy into the thought of neighborhood regulations/enforcement by each other. If a neighborhood doesn't have an association then it reverts back to the deed restrictions and when the final plat is recorded.

City Manager's Report

Mr. Howard discussed the following item:

- 1. Budget FY 14-15: started working on the draft budget this week
- 2. District Court/ Hall of Justice building- repair parts for the cooling tower are in and completed.
- 3. Sidewalk repair on S. Second Street by Elks Building- the sidewalk retention wall needs to be repaired and will take approximately 2 weeks. That portion of the street until the exit of Community Trust Bank parking lot will be closed to the public for that duration.
- 4. HVAC unit at City Hall needs to be replaced due to it being over 20 years old. Currently getting a study completed to see what all is needed and estimated costs could reach to \$200,000.00. Once the study is completed the city will go out for bids.
- 5. Broadcasting of various meetings on channel 12 in the commission chambers- Mr. Howard announced that the city is looking at replacing the microphones, mixing board and a modulator that send the video to Time Warner Cable. The city is working on improving the quality of meetings so citizens can see the meetings easier on TV.
- 6. Meeting with District 7 State Transportation Cabinet regarding the turning lanes on Barnes Mill Road located in front of Richmond Centre.
- 7. Blacktop plants opening soon and the city will be filling in potholes with asphalt instead of the temporary coal patch.

1. Announced that he visited a town in Alabama that also has an Army Depot that is currently underway in the process of destroying old chemical weapons. He commented that the city is still very viable. Mayor Barnes asked if the base would be closing after the chemicals are destroyed. Commissioner Blythe responded that the local university plans to utilize that space.
