#### **Richmond Utilities- Scott Althauser**

Mr. Althauser updated the commission on the new sewer pipe construction for Big Hill Ave./ East Main Street. He noted that that the project is near completion and the entire section of project will be milled and paved when the city does paving soon. All expenses of the paving will be covered by Richmond Utilities for the project.

## City Manager's Report

# Mr. Thomas discussed the following items:

- 1. The city pavement will be completed by the Allen Company through a state contract. The list of streets for mill and pavement was provided to the commission with estimated costs. Mr. Thomas noted that he will bring an order for the next meeting to be voted on moving the additional funds. Approximately \$400,000.00 for paving through MAP monies, total received this year is \$617,000.00 with utilizing the remaining for salt this winter. Additional streets will be paved with bonds which are being pulled for Hidden Hills and High Meadows.
