

**ORDINANCE NO 16-18**

**AN ORDINANCE OF THE CITY OF RICHMOND ADOPTING AN ANNUAL BUDGET FOR THE SECTION 8 HOUSING DEPARTMENT FOR THE FISCAL YEAR 2017 BY ESTIMATING REVENUES AND RESOURCES AND APPROPRIATING FUNDS FOR THE OPERATION OF CITY GOVERNMENT.**

**WHEREAS**, an annual Section 8 Housing budget proposal has been prepared and delivered to the City Commission, and

**WHEREAS**, the City Commission has reviewed the Section 8 Housing budget proposal and necessary modifications have been completed as necessary,

- (3) The City Clerk is hereby directed to publish a copy of the Fiscal year 2017 Budget Ordinance in accordance with KRS 424.240


