## **PROJECT #1: Work Description: Gel Coat Interior Slide Painting**

- Repair all minor structural repairs in ride path\* (Minor repair does not require laminating)
- All repairs to be done with vinyl-ester resin
- Re-caulk all seams
- Seams to be caulked with Sikaflex or 3M 4000
- Prepare interior ride path for Gel Coat
- Lay non-skid at start tub
- Refinish interior ride path of slide with Gel Coat
- Gel Coat will be applied to a thickness of 18-24 mils.
- Premium Gel Coat must be used
- Gel Coat Colors- Blue, Teal Green, Purple – color match to be determined after bid is awarded
